25-314 (a)(4)- Whether issuance of the license would create or contribute to an overconcentration of licensed establishments which is likely to affect adversely the locality, section, or portion in which the establishment is located.

25-314 (b)(4)(E) – The establishment is a full service grocery store which is newly constructed with a certificate of occupancy issued after January 1, 2000, or is an existing store which has undergone renovations in excess of \$500,000 ... (ii) during the preceding 12 months in which an application is made.

We designate Mitchell Aaronson as our representative of this group at all hearings should we be granted standing.
